- 8. <u>Approval of the FY223/24 Budget Calendar</u>
 - CFO Hill reviewed the proposed budget calendar

Council Member Hull moved to approve the FY23/24 Budget Calendar as presented Mayor Overson seconded the motion

9. Approval of 2023 UFA Board Meeting Schedule

- Council Member Stewart suggested that the December meeting be moved up 1-week to accommodate for the Christmas holiday meeting challenges (from December 19 to December 12)
- All Board Members agreed to this change

Council Member Stewart moved to approve the 2023 UFA Board Meeting schedule, with the change for the December meeting to 12/12 as discussed Mayor Stevenson seconded the motion

10. Fire Chief Report

- Legislative Update Ashley/Dave Spatafore
 - An update was provided on what bills are expected this upcoming season
 - HB145 WL Urban Interface
 - The intention of this bill is to address wildfire risk in interface areas
 - The state has no plan on how to address this
 - A state-wide definition of WL Urban Interface is needed
 - FFSL is studying how best to move forward
 - UFA and the State Fire Chief's Association has been involved and language is now being drafted that all stakeholders will review
 - Developmental standards for home builders
 - Addressing road width, etc.
 - Grant Funding for Emergency Management
 - Emergency Management/Division Leader Mecham is working on obtaining a grant for small business and homeowners to develop a flexible funding pot
 - This will allow for funding while awaiting insurance claims
 - Retirement
 - Discussion regarding reducing the year separation to 60-days
 - Also working on Tier 2 and backfill
 - Ashley Spatafore explained that currently, anyone retiring from a governmental job must wait 1-year to come back into public service or their retirement benefits cease
 - Dave Spatafore explained the funding and obligations behind the Tier 2 funds and the Tier 1 and Tier 2 issues
 - With retirement changes, it appears that the senate is holding firm, any retirement changes should have an uphill battle
 - Communications
 - A Legislative Committee consisting of UFA staff and some Board Members will be compiled, as has been done in the past
 - This Committee receives communications from the Spatafore's with current bill information and provides feedback on UFA's position
 - This communication document is then given to legislators each week, so they are current on our stance as a board and organization
 - The Spatafore's encouraged all Board Members to keep an ear out and notify them if they hear any talk
 - FY23/24 Budget Update
 - The budget kick-off meeting was held with all Division Leaders this past week
 - Chief has asked that all requests fit into his priorities; Health & Wellness, Community Relevancy, Continuous Improvement
 - COLA and market position will be the biggest impact
 - The CPI is high, but will see where it lands
 - Final agency comparison numbers and data are still being collected
 - South Salt Lake and Park City did approve a large wage increase which will have an impact on our position
 - Looking at ways to reduce overtime for personnel
 - In the past, the approach was to over hire
 - Chief Burchett plans to look at a multiplier
 - This would take the total seats, multiply 3.7/3.8 for each position as on average 3.7/3.8 bodies are needed to fill vacancies due to sick and vacation
 - Hiring to a multiplier will drastically reduce the need for OT
 - Current trending is that OT is not as coveted as it was in the past



- Fuel Projections
 - Projections for fuel continue to rise
 - Logistics continues to monitor usage and continues with communication to the field regarding the use of state fuel sites and the savings gained with use
 - Council Member Stewart asked if tax exemption was given when using stations outside of the state fuels sites
 - It was found that when fuel is purchased on the WEX gas card at regular gas stations, the tax is removed from the bill prior to payment
 - Thus far there has been over \$30,000 of savings with the use of state fuel sites
- Mandatory Staffing Update
 - The new policy provides more flexibility and control for personnel for when they work
 - The need for OT is still there, but the current trend is not as much mandatory
 - December 2020 the average sick leave was around 5 per day, this December it is 7.8 per day
 - To help with the Paramedic shortage, a Paramedic Lateral Process was completed, and 21 Firefighters are on the interest list to attend Paramedic school
 - The Paramedic over market has accomplished it's intent and is making the biggest impact on interest in that rank
 - With the new policy and an increase in Paramedic personnel, mandatory staffing should be less of a burden on personnel

• Promotions

- Chief introduced Dustin Dern as the new Assistant Chief of Operations, AC Higgs is retiring at years end
- Replacing Dustin Dern as Operations Chief is Battalion Chief Wade Russell who was not available for today's meeting
