- Chair Perry asked for a moment of silence to honor the passing of Chris Cage

5. <u>Committee Updates</u>

- Benefits & Compensation Committee
 - No meeting held
 - Pay comparison data will be available for discussion in November with a review by Chair Dahle prior to the November Board Meeting
 - As a reminder, the Board decided to consider a mid-year market adjustment when the budget was adopted, this update will provide the information necessary for the Board to hear the information in November and make the decision about the Market Adjustment at the December meeting
- Governance Committee
 - o No meeting held
 - o Meeting scheduled for 9/22/20 to discuss the Draft Board Policies
 - o After the review by the Governance Committee, staff anticipates a packet of policies will be presented to the Board for consideration at a future Board Meeting

• Finance Committee

- No meeting held
 - Council Member Stewart stated that Home Depot has offered to donate equipment for the Light the Night event in October
 - This request will come before the Board in October for an official vote, but there is a need to allow the notification of acceptance prior to next month
 - The notification of the donation was not made in ample time for the agenda
 - The Board agreed to accept the donation

6. "Stress Test" Reduction by SLCo to Canyon Fee and Emergency Management April 20, 2021

- SLCo has indicated that due to budgetary issues, they will be conducting another Stress Test that could reduce the funding for both Emergency Management and the Canyon Fee
- Assoc. Deputy Mayor Reberg stated that the Stress Test is being applied to every General Fund item

Mayor Dahle arrived

- He also stated that these two areas are the last areas that SLCo wishes to apply the Stress Test
- Chief Petersen pointed out that the Board needs to discuss what this would look like since this will hit mid-budget cycle
 - The current budget was completed with the impact of the approx. \$600,000 revenue loss
 - Until SLCo makes further decisions, there is no reason to discuss this now

• Chief Petersen wants the Board to just be aware as there is plenty of time to work on this

8. Fire Chief Report

- EMAC Update Oregon/California
 - Chief followed up to the email he sent the Board showing the information about the EMAC and USAR Deployment to Oregon
 - Originally, the USAR request was for only four personnel, this made it a much easier
 decision to support the EMAC request, however, California was not able to fill the USAR
 request from Oregon, resulting in FEMA adjusting their ask of us from the four personnel
 to the full 80 personnel Type 1 response (35 of those from UFA alone)
 - Chief stressed that in responding to these requests, the main concern is ensuring our staffing levels are good here at home
 - Chief also discussed the probability that fires such as those in Oregon are a reality here in the Salt Lake Valley
 - Southern Oregon's climate and configuration of homes is similar to ours
 - UFA personnel deployed to these events offers training and experience that is unparalleled, and these events are allowing more and more personnel the exposure
 - Chief feels that legislative work must take place to create a more streamlined process for Utah to request and pay for aide from other states
 - There is a need for a big picture plan, this will take some time, but is necessary to ensure help is requested, arrives, and is reimbursed to ensure support
 - Chief expressed his appreciation to personnel who have stepped up to ensure the picklist is full
 - Thus far, all stations have been staffed without using Mandatory Staffing for the last three days
 - There is an uptick in COVID related cases and that may further challenge maintaining staffing without applying Mandatory
 - Chief also understands this is a large number of resources to send, but values the support from the Board to pay it forward
 - Pointed out that in the Fire Service, no one can do it alone, you can never staff for fires of this magnitude, but have a better chance in the fight, if giving/taking with neighbor agencies happens
- Automatic Vehicle Location (AVL) Response with New CAD
 - o With the improved relations within the valley, AVL dispatching will be implemented
 - The closest apparatus will respond, rather than dispatching by station
 - This type of response is one where the communities win every time
 - There will be challenges, especially on the fringes of boundaries
 - Chief Petersen is asking that municipalities be patient
 - The plan is for a 6-month trial period
 - Unit hours will be tracked
 - The total unit hours that UFA provides to neighbors and receives from neighbors will be identifiable, this is more important than the number of incidents/events alone
 - These hours will help identify where there may be inequities in response
 - There are options available to help balance these inequities, the balance will take place on the administration side whenever possible
 - During this time, BC's throughout the valley will watch for challenges
 - These challenges will be addressed operationally between agencies

- If they continue to cause issues, Chief Petersen will work with the other Chief's toward solutions
- Chief wants Board Members and their councils to realize that their communities will begin seeing apparatus from other agencies and areas and that their stations will be responding beyond their boundaries as well
- The test will begin the end of this month
- All agencies within the valley are onboard
- Captain Promotional Process
 - o The 3-day Captain Boot Camp has completed, with 50 attendees taking part
 - o A portion of the training included a UCLA professor discussing Compassionate Leadership
 - The professor has worked extensively with California Fire Agencies and has been well received here in the UFA
 - She will also return to take part with the Battalion Chief Boot Camp
 - o A written exam and an assessment will be held in October
 - o A promotional list will then be created and active for promotions for 2 years
- Ivory Homes Land-Swap Update AC Burchett
 - Ivory Homes produced a master plan map for the proposed project surrounding the Training Facility
 - o The purpose of the land swap was to provide a buffer to the residential areas from the facility
 - With the new master plan, the proposed land was still adjacent to homes and not as isolated as was communicated to UFA
 - o UFA has decided to not pursue the swap and will close this project



Request:

Officially approve the acceptance of donated goods listed below from Home Depot.

Consider acceptance of an ongoing annual donation from Home Depot in support of this event, acknowledging that acceptance is based on ensuring the donation follows the UFA Gift Policy, VI, C4, S6.

Background:

At the September 15, 2020 UFA Board meeting, a proposal was presented to preliminarily accept a donation from Home Depot to help support UFA's participation in the 'Light the Night' event. Fire departments around the Nation light their facilities in red to honor fallen Firefighters during the National Fallen Firefighters Memorial Week. This event occurred September 27th- October 4th.

The offer from Home Depot came at a time when staff could not get the request on the UFA Board agenda prior to posting. The Board agreed to officially accept the donation at the October 20, 2020 meeting.

The donated goods included portable outdoor flood lights, LED lights, and extension cords. The approximate value of donated goods is \$2,600.

(Approving Ongoing "Light the Night" Donations)

A RESOLUTION AUTHORIZING UNIFIED FIRE AUTHOIRTY TO ACCEPT DONATIONS FOR ANNUAL "LIGHT THE NIGHT" CEREMONY

- A. Unified Fire Authority (UFA) is an interlocal entity that provides fire protection and emergency medical response for its member entities.
- B. Each year, a national commemorative ceremony established by the National Fallen Firefighter Foundation takes place in late September, early October to commemorate those firefighters who have died in the line of duty during the previous year.
- C. UFA participates in this event by engaging in various commemorative events such as flag ceremonies and the illumination of its stations with special lighting. Members of the community, including businesses, have typically offered to donate supplies, such as lighting and electrical equipment, to facilitate these commemorative events.
- D. UFA policy requires approval by the Board of Directors for any donation exceeding \$1,000 in value. In 2020, a donation was received in the approximate value of \$2,600 dollars. The Board tentatively indicated that it approved of acceptance of such donation in a prior Board meeting, but wishes to formally accept this donation and direct that UFA is authorized to accept donations for this particular event in the future without further Board action, up to a proscribed limit.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the Unified Fire Authority:

- 1. The Board hereby approves, per policy, the acceptance of the donation for the 2020 Light the Night Celebration made by Home Depot in the form of lights and other electrical equipment with an approximate value of \$2,600. The Board of Directors expresses its gratitude to Home Depot for the donation and its continued support in commemorating fallen firefighters.
- 2. The Board hereby provides a continuing approval for the acceptance of materials or other support for the Light the Night ceremony in future years, without the need for further, specific approval from the Board of Directors, up to the amount of \$3,000 per year in cumulative donations. Donations in excess of this amount will be subject to UFA policy for Board approval if required by policy.
- 3. In the event a Board Policy is adopted that is in conflict with this Resolution such that the Fire Chief is allowed to accept donations in a larger amount than provided herein without prior approval by the Board, such policy will govern and supersede this Resolution.
 - 4. This Resolution shall take effect on October 20, 2020.

SUBJECT: Board Agenda Item: Consideration of COVID-19 Expenditures for Substantially Dedicated UFA

Employees

On September 2, the United States Treasury Office provided updated guidance on the use of CARES funding. The guidance now allows CARES funding to cover the full amount of payroll and benefit expenses of employees "substantially dedicated" to mitigating or responding to the COVID-19 public health emergency. Firefighters and emergency medical responders are presumed to be included within the scope of such eligible employees.

After reviewing the guidance and discussing the issue with members of the County District Attorney's office, UFA believes that payroll costs pertaining to employees that work in the stations, i.e. those who respond to patients, meet this new guidance and are eligible for CARES funding.

With the second tranche of CARES funding being allocated to local governments by Salt Lake County, we want to discuss your entity's interest in using CARES funding to offset a portion of its member fee. This approach would not distribute any additional funds to the UFA, however, you would be able to allocate some of the CARES funding you received to your member fee. For UFSA members, you could contribute to the UFSA to offset their member fee if there is a desire to do so.

We understand and agree that we need to be careful how we interpret "substantially dedicated" and that a consistent approach across UFA is important. We don't believe UFA should attribute 100% of UFA member fee costs for potential CARES funding. The UFA's member fee breaks out the cost to staff the engines and trucks. These employees are responding to calls and are pretty clearly "substantially dedicated" to mitigating the public health emergency. The table below breaks down the member fee and shows the impact by UFA member.

Using this methodology, 65.71% of the member fee can be attributed to the payroll costs of the employees working directly in our stations and meet the requirements for CARES funding. We are not suggesting that UFA members use \$30.7 million of CARES funding for UFA services. We are providing this calculation to facilitate, as an option, UFA members offsetting previously paid member fees with CARES funds and believe that up to \$30.7 million of member fees can reasonable be attributed to "substantially dedicated" employees under the new guidance. Each entity will need to decide its interest level in using CARES for this purpose, but we hope the Board can reach a consensus recommendation to member entities on the potential use of such funding..

As a reminder, this conversation is not about providing additional member fee to UFA. It is UFA providing a framework for its members, including UFSA, to attribute CARES funding to each entity's member fee costs that qualify under the updated guidance.
