2. Recognition of (5) NIX Construction employees and Mr. Robert Conder

- Captain Aldridge explained how vital these individuals were during a December incident
- NIX Construction employees enabled access for our apparatus on scene
- Structural Engineer Robert Conder provided structural assessment and shoring plans on scene
- All were awarded the Fire Chief's Award of Excellence and a certificate of recognition

9. <u>Legislative Update-</u> Dave Nicponski, UFA Lobbyist

- Five issues:
 - o Retirement Equalization
 - 3.74 increase to raise budget to compatibility with Tier 1
 - Bill sponsor is looking for other funding source
 - o Fireworks Legislation
 - Board has been working with stakeholders, municipalities and the industry. With this being a Committee Bill it may get through the process quickly
 - o Special Service District Bill
 - State Auditor will oversee. Applies to schools, UPD, and UFA.
 - State Procurement Bill
 - Clarifies purchasing rules and regulations for agencies
 - o Ambulance Service
 - Gold Cross being challenged by some jurisdictions

10. Sub-Committees Structure and Vacancies

- With members of the Board leaving, there are vacancies within the sub-committees
- It was clarified that anyone can attend any of the sub-committee meetings, but unable to vote
 - o Voting is for designated members of the committee only

Finance Committee

- Committee makeup was explained
- o The issue of achieving a quorum was discussed
- Conversation regarding tension within the committee with concerns with the voting power of UFA
- o This committee has the most say on the budgets affecting municipalities
- Mayor Silvestrini suggested a change in the Finance Committee structure:
 - UFSA Board will elect four members to the Finance committee and invite Alta, CWH, and Holladay to have seats as well
 - This should equalize the tension between UFSA and member cities

Mayor Silvestrini made a motion on the Finance Committee structure Councilmember Bush seconded motion All voted in favor

*Note: All sub-committees are being treated like a public meeting and require a quorum

Mayor Silvestrini made a motion to confirm and nominate those on committees Councilmember Stewart seconded motion All in favor

11. Board Member Compensation Discussion

- Councilmember Stewart has brought this discussion to the forefront
- All agreed that this is not a good time to consider this, given the history of UFA
- No support for this discussion

12. Fire Chief Report

- 2017 Accomplishments, wicked issues and 2018 initiatives
 - Board requested additions to poster: audit info, continued delivery of great service, Board oath
 - o Chief asked that in addition to stations, this be displayed at city offices for public viewing
 - o This is a draft only; Chief Petersen just wanted to get this out at year end to show what we have done and what has yet to be done
 - o Generated by Chief Petersen and Command Staff
 - Remarkable to look at the past year and see changes in the environment and the improvements/progress

Budget Process

- Last year's budget was 3 pages for all of UFA
- o All divisions have been broken out, will have a budget message, performance measures, action items from the Strategic Plan
- o Budget is now 130 pages
- CFO Hill should be ready with a balanced budget with proposed expenditures by the 1st week of April
- o HR and labor conducting a market study this year
- o Staff is working with labor for information and should be ready in February

Surplus: Turnouts

- UFA has expired turnouts that are no longer certified for firefighting purposes
 - Some departments cannot afford to meet national standards, but UFA cannot afford not to meet them
- o CLO Roberts has drafted a liability waiver for agencies who wish to receive them as a donation
- The Board would like a say in surplus donation and Chief Petersen would like to validate donations through the Board
- o Agencies requesting our turnouts: Cedar Fort Volunteer Fire, JATC, Kamas HOA
- o Discussion regarding resale followed, UFA deems no value to expired turnouts

Mayor Silvestrini made a motion; the Surplus Policy is muddled and the Board would like a say in surplus donation

Councilmember Stewart seconded motion

All in favor

13. Quarterly Report- CFO Hill

- Member fees are the bulk of revenue in the General Fund
- Ambulance revenue is on track
- Grant/Donations- an EMS grant was not included, but it is there
- Majority of our expenditures are with employees, we are a people-based organization

 - o This is due to no brown outs, established a minimum of 114 staffing

 - Note: Fire school will take place in May for Board members and an orientation will be planned for new Board members.
- WL Fund; all revenue received stays in this fund for WL use
- Emergency Services tracking as expected
- The only concern is OT and we are keeping an eye on it

Cedar Fort Volunteer Fire Department has traded their 2015 CanAm Commander Max UTV (with light bar) for *two of UFA's surplus fire apparatus and they are interested in a third one. The description of those apparatus and their surplus values are listed below, along with the NADA value of the CanAM:

Apparatus Description	Surplus Value
*1997 Type VI Engine (brush truck)	\$2,500.00
*1992 Water Tender	\$3,500.00
2007 Crimson Type III Engine	\$35,000.00
Total surplus value	\$41,000.00
Less the NADA value of the 2015 CanAm	-\$18,000.00
Balance due to UFA:	\$23,000.00

The value of the apparatus trade to UFA is:

- 1. We are moving these pieces of surplus apparatus off of our books at one time, rather than waiting for each piece to be auctioned individually.
- 2. The trade would improve the response capability of a neighboring fire department that periodically requires UFA's assistance.
- 3. The CanAm would be of value to and used by one of our Divisions.

<u>Proposal</u>: As Cedar Fort is a neighboring, volunteer fire department that UFA responds to, we would like to offer them a 50% discount on the balance due. If this proposal is approved, the adjusted numbers would be:

Balance due to UFA prior to discount	\$23,000.00
Less the 50% discount	-\$11,500.00
Adjusted balance due to UFA:	\$11,500.00

<u>Action requested</u>: Consider and approve the proposal above. If approved, UFA will memorialize the surplus agreement, the trade-in and invoice Cedar Fort Fire Department for the balance to be paid in full within 12 months.
