4. Approval of Minutes

Councilmember Stewart made a motion to approve the January 16, 2018 minutes Mayor Peterson seconded motion

5. Administer Oath Of Office for Board Members

Councilmember Martin and Mayor Westmoreland absent and will receive oath at March meeting

- 6. <u>Legislative Update- Dave Nicponski, UFA Lobbyist</u>
 - Handed out a sheet of 52 bills that are current track/watch items
 - Discussion concerning the watch list

7. <u>Committees Updates</u>

- Benefits & Compensation Committee
 - o Goal is to do an initial look at all benefits and prioritize where the benefits should fall
 - o Expecting to get a final number mid-March to present to the Finance Committee
 - o Typically we have tried to target a 3-3.5% increase
 - o Will be difficult to do COLA this year
 - We are trying to move our agency to the top 3rd or #3 position

- Arriann Woolf and Cal Ricotta explained the comparison data between UFA and other agencies in the surrounding areas that are similar to UFA
 - This year there is better comparison with anything that contributes to "income"
 - VEBA contribution, longevity bonus, etc.
 - Much discussion about using/continuing to use Park City in the data
 - · Some feel that it skews the data and they are an outlier
 - You can't do a comparison and ignore the top paying department
 - Chief Petersen would rather say #4 than omit Park City
 - Historically they have been used in comparisons
 - Chief will have labor weigh in
 - HR will provide updated attrition data and prepare a report on the impact of recruitment/retention numbers
 - Continue discussion at the next meeting on a benchmark (3rd or #3) with relation to the market
 - It was suggested to use a flexible system; base on the group that we are having a
 difficult time keeping (raises based on difficulty of retention for that position)
 - Next meeting: resurrect debate and get motion to take a position before passing the recommendation onto the Finance Committee
 - An email will be sent out prior to March meeting with all updates
- Governance Committee Nothing
- Finance Committee
 - o Both meetings are set for the budget process & are waiting for the budget to be built
 - o Benefits and Comp will have something to the Finance Committee by first of April
- 8. Valuation of Cedar Fort Volunteer Fire Department Apparatus Surplus Swap/CanAm
 - Have traded two apparatus for the CanAm
 - They wish to have the Crimson Pumper
 - Since they are a small volunteer department, we are discounting 50% for the pumper, charging them \$11,500.
 - o They are our neighbor to Eagle Mtn.
 - Chief Petersen wants to bring these issues to the Board when discounting more than usual

PREAMBLE

Unified Fire Authority is a political subdivision, duly organized and existing under the laws of the State of Utah.
